(C) Caste Certificate for SC / ST / OBC Candidate in prescribed format issued by Competent Authority, OBC Candidates are required to produce current (not prior to 2022 – 2023) OBC Caste Certificate in prescribed format which should have clear mention about Non – Creamy Layer status.

(D) Lower half portion of Admit Card of CBT

(G) Disability Certificate in case of PwBD

(H) Photo Identity Card issued by Office / Aadhaar Card
