1. After declaration of Provisional Panel part-10 & Replacement Panel part 1, RRC-WR has conducted Document Verification of 157 non PwBD candidates ( 10<sup>th</sup> stage ) and 26 PwBD candidates 6<sup>th</sup> Stage from 4<sup>th</sup> January'2022 to 6<sup>th</sup> January '2022 and on 23-02-2022 (2<sup>nd</sup> & Final chance for absentees ). Pending cases of some candidates of earlier DVs have also been finalized.
2. On completion of the formalities as per the procedure laid down by Railway Board, Railway Recruitment Cell, Western Railway further declares the Provisional Panel Part-11 of 6 non PwBD candidates & 7 PwBD candidates and Replacement Panel Part-2 of 93 non PwBD candidates on **04-04-2022**.
