1. The Computer Based Test for GDCE No. 5/2019 for the post of Senior Clerk cum Typist was held on 27th & 29th June 2022.
2. Prov. Merit list of 812 employees qualified for Typing Test for the post of Senior clerk cum typist was declared on 10-10-2022.
3. The Common Computer Based Typing Test (CBTT) for the post of Junior Clerk cum Typist and Senior Clerk cum Typist was held on 28th November 2022 at Ahmedabad and result of CBTT was declared on 13-02-2023.
4. Prov. Merit list of 101 employees qualified for DV was declared on 16-2-23. DV was held on 20-02-2023 at RRC office. Some employees who were called for DV of Jr. Clerk cum Typist on 20-2-23 were also found eligible for DV of Senior Clerk cum Typist according to their merit thereby changing the cut off mark.
5. Considering preference for empanelment in GDCE notifications given by the employee at time of DV, prov. panel part-1 of 77 employees is hereby declared subject to condition that their existing medical fitness is Cee one and above.
6. **If the present medical fitness of any empaneled employee is found to be below Cee one then medical examination of that employee will be conducted in Cee one category by the concerned Division.**
