1. The Computer Based Test for GDCE 03/2019 for the post of GG, Sr.Comml cum Ticket clerk was conducted on 27th June & 29th June 2022.
2. Prov. Merit list of 101 employees & 135 employees qualified for DV for the post of GG & Sr.Comml cum Ticket clerk respectively was declared on 10-10-2022. Out of 236 employees, 101 employees have qualified for both the posts whereas 34 employees have qualified for the post of Sr.Comml.Clerk cum Ticket Clerk.
3. DV of 135 employees was held from 6-12-22 to 8-12-22 at RRC office. Medical examination of employees was conducted by respective Divisions/ Units.
4. Considering medical fitness and preference for empanelment in GDCE notifications given by employee at time of DV and the preference for the posts of GG /Sr. CCTC taken at the time of online application form the employee, RRC hereby declares the Provisional panel part-1 of 27 employees for the post of Goods Guard and 66 employees for the post of Sr.Comml. cum Ticket clerk.
5. As per Hon'ble CAT, Mumbai's order dated 5-12-22 in OA 944/2022, the result of examination held on 27th & 29th June'22 is subject to the outcome of decision of the said OA.
