NOTIFICATION NO. 01/2012-13 GDCE/TRAFFIC & COMML. DEPARTMENT

1. Result of written examination of ASM conducted by RRC-Western Railway on 08-01-2017 was declared on 15-02-2017 and Corrigendum dated 08-03-2017 in which 464 candidates qualified for Aptitude Test. Aptitude Test of these 464 candidates was conducted on 20th & 21st March, 2017 at Rail Nikunj-BCT.
2. Result of Aptitude Test to qualify for Document Verification was declared on 31-03-2017. Document Verification of 58 candidates of Regular list and 30 candidates of Additional list was conducted on 24th & 25th April, 2017 respectively.
3. After verification of original documents and in compliance of procedure laid down by Railway Board, Railway Recruitment Cell, Western Railway hereby declares Provisional Panel Part-I of 51 candidates for the post of ASM (list enclosed).In this list Roll numbers are arranged vertically in ascending order and not as per merit. Empanelment of 7 candidates is kept pending for want of some documents/clarification/absenteeism.
4. The result of successful candidates is only provisional.
5. Empanelled candidates have to pass prescribed medical examination before their appointment.
6. Allotment of division shall be decided in due course at HQ level and shall be subject to availability of vacancies, option etc. Offer of appointment shall be dispatched by respective divisions.
7. While due care has been taken in preparing the result, RRC-Western Railway, Mumbai reserves the right to make amendments to the provisionally declared panel at any subsequent stage. If any discrepancies or malpractices is noticed or brought to notice of RRC at any stage then RRC-WR reserve the right to delete the candidates from the notified panel. The decision of RRC in the matter shall be final.
8. This is only the provisional panel (NOT the FINAL Panel) and does not confer upon the candidates any right for appointment in Railway Service.
9. For any legal dispute the jurisdiction will be Hon'ble CAT Mumbai/High Court Mumbai.
