**PROVISIONAL RESULT OF COMPUTER BASED TEST (CBT )**

1. Result of CBT conducted by RRC –Western Railway on 16-10-2016 & 24-10-2016 is hereby declared for Aptitude Test of ASM (List enclosed ).The result of successful employees is only provisional. Roll Numbers are arranged vertically in ascending order and not as per merit. This result is also available on website [www.rrc-wr.com](http://www.rrc-wr.com)
2. **1272** employees (i.e. eight times the number of vacancies of ASM - 159) following community wise reservation rules are qualified for Aptitude Test which will be tentatively scheduled in last week of May'2017 or in 1<sup>st</sup> half of June'2017. Exact date will be notified shortly. Candidates are informed to be in readiness for Aptitude Test. Employees are advised to visit RRC's website regularly to know the exact date of Aptitude Test.
3. Online Call letter for the Aptitude Test will be made available 10 days prior to scheduled date of Aptitude Test from the link available on RRC's website [www.rrc-wr.com](http://www.rrc-wr.com) .
4. **To familiarise with nature of Aptitude Test, a separate link to RDSO's website is available on RRC's website [www.rrc-wr.com](http://www.rrc-wr.com) .Employees are advised to use this facility.**
5. Employees are advised to bring 2 sets of passport size colour photographs. They are also advised to bring "Relieving Letter" from their respective Unit Incharge to attend Aptitude Test on the scheduled Date.
6. No request for change of date for Aptitude Test will be entertained. Employees are advised to be prepared for more than one day stay, if required.
7. Candidates qualified in Aptitude Test will be called for Document Verification of ASM following community wise reservation rules giving 70% weightage to the marks secured in Written examination and 30% weightage of marks secured in Aptitude Test and their preference of the post whereas candidates will be qualified for Document Verification for the post of Goods Guard following reservation rules etc. based on their marks of Written exam only and their preference for the post.
8. While due care has been taken in preparing the result, in case of any inadvertent error/s is noticed at any stage RRC, Western Railway reserves the right to rectify it at later stage of selection procedure.
9. This is only the provisional result and NOT the FINAL Panel and qualifying for Aptitude Test does not entitle any employee to be appointed on the respective post.
10. Final panel for ASM shall be prepared on the basis of result of Written examination, Aptitude Test & Document Verification. Final panel of Goods Guard shall be prepared on the basis of result of written examination and Document Verification.
11. RRC, Western Railway reserves the right to declare any employee unsuccessful or delete his /her name from the notified result /panel at any stage of the selection procedure, if any discrepancy or malpractice is noticed or brought to the notice of RRC at any stage. The decision of RRC in the matter shall be final.
12. RRC will not entertain any individual queries in this regard.
13. For any legal dispute the jurisdiction will be Hon'ble CAT Mumbai / High Court Mumbai.
