- 2 The allotment of post & division shall be decided in due course by Head Quarter Office and shall be subject to availability of vacancies, medical fitness, verification of certificates of recognized Scouts & Guides and Educational qualification, etc.
- 3 Offer of appointment shall be dispatched by respective Division/ Unit.
- 4 Selected candidates will have to give a written declaration as per Annexure 'H' of the Employment Notification dated 07-11-2022. If the candidates violate any of the said declaration furnished by him/her, he/she should be taken up under DA&R by the concerned Authority on the recommendation of the State Chief Commissioner / District Chief Commissioner, as the case may be.
- 5 List of qualified candidates is not as per merit but is as per Registration Numbers arranged in ascending order.
- 6 While due care has been taken in preparing in the result, in case of any inadvertent error/s is noticed at any stage, RRC-Western Railway reserves the right to make amendments to the provisionally declared panel at any subsequent stage.
