 - (C) Certificate for proof of Date of Birth as mentioned in the Notification
 - (D) Caste Certificate for SC / ST / OBC Candidate in prescribed format issued by Competent Authority, OBC Candidates are required to produce current (not prior to 2023 – 2024) OBC Caste Certificate in prescribed format which should have clear mention about Non – Creamy Layer status.
 - (E) Lower half portion of Admit Card of CBT
 - (F) Disability Certificate in case of PwBD
 - (G) Photo Identity Card issued by Office / Aadhaar Card
