1. Considering balance vacancies after candidates empaneled in 8 prov. part panels & 3 Replacement panels and vacancies against non-materialization, 39 PwBD (LD) candidates are being called for Document Verification scheduled on **3-7-2024 & 4-7-2024** at RRC Office, Grant Road, Mumbai. Document Verification of non PwBD candidates will be held shortly.

Note : LD(OA) candidates are not shortlisted in this DV due to non-availability of vacancy in LD (OA).

3. A link to download call letter for Document Verifications will be made available on the website shortly. Intimation regarding Document Verification is also being sent by email /SMS to shortlisted candidates.

Candidates who remain absent for DV on scheduled date are directed to attend the DV on the **Block Date 11-07-2024** at RRC Office, Grant Road, Mumbai with Call letter already issued. No separate Call Letter for Block Date will be issued. **No further chance of Document Verification will be given to candidates who remain absent on Block Date and their candidature will be treated as CANCELLED.**

4. Common Instructions:

- i) Candidates found eligible in Document Verification will be directed for medical examination at nominated Railway Hospital. They are advised to plan their journey from Mumbai to their "Venue of Medical Examination" in advance. Candidates are advised to come prepared for stay at concerned venue for 3-4 days.
- ii) Request for change of " Date of DV ,Venue of Document Verification ,Medical examination" will not be considered.
- iii) Candidate must bring copy of Application Form and following Documents / Certificates in Original along with two sets of Photocopies of all Documents duly self attested mentioned as under:
 - A. Lower portion of call letter, issued to candidates during CBT.
 - B. Mark Sheets and Certificates of all Educational / Technical qualification mentioned in the Application Form / Notification.

- C. Gazette Notification and / or any legal Document in case of formal change of Name as mentioned in Notification.
 - D. NCVT (NTC/NAC) /SCVT certificate and mark sheet for CCAA candidates, if applicable.
 - E. Certificate for proof of Date of Birth as mentioned in the Notification. In absence of relevant Date of Birth Certificate, candidature of Candidate will be Cancelled (Birth Certificate will not be considered as valid documentary proof).
 - F. Caste Certificate for SC / ST (as per Annx. I of Notification), OBC Candidate (as per Annx. II of Notification) in prescribed format issued by Competent Authority. OBC Candidates are required to produce current (not prior to 2023– 2024) OBC Caste Certificate in prescribed format which should have clear mention about Non – Creamy Layer status (as per Annx. II A of Notification).
 - G. Income and Asset Certificate for Economically Weaker Section (EWS) (as per Annx. III of Notification).
 - H. NOC from serving employees with Date of Appointment from current employer
 - I. Self Declaration (as per Annx. VII) and Discharge Certificate / NOC in case of Ex-Servicemen
 - J. Disability Certificate in case of PwBD Candidates (as per Annx. V(A), V(B), V(C) of Notification)
 - K. Photo Identity Card as mentioned in CEN No. RRC-01/2019 (any One) and photo copy of both side of Aadhar Card with Original.
 - L. Receipt of off-line Payment, if made through a challan at SBI Branch or Pay – in – Slip at computerized Post Office.
 - M. Income Certificate for Waiving Examination Fee for Economically Backward Classes as per Annexure – III A
 - N. Minority Community declaration on Non - judicial Stamp Paper as per Annexure – IV of CEN
 - O. Self-Certification by the Transgender Candidate, in case applicable.
 - P. J&K domicile Certificate, if applicable
 - Q. Decree of Divorce / Judicial Separation from the Competent Court of law and Affidavit stating that the Candidate has not re-married, in case applicable.
 - R. In case of Widow, Death Certificate of Spouse and Affidavit stating that the Candidate has not re-married.
- iv. Candidates are also required to carry 6 copies of photographs similar to scanned copy of photograph uploaded in ONLINE Application Form and 6 copies of latest photographs
6. The candidature of all the shortlisted candidates for DV & ME is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency/deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRBs/RRCs at any stage of the recruitment process.
