DECLARATION OF PROV. REPLACEMENT PANEL PART-4

1. Based on the result of Computer Based Test (CBT) declared by Railway Recruitment Board- Ahmedabad on 22-12-2022 and Physical Efficiency Test (PET) conducted from 11-01-2023 to 21-01-2023 at Ratlam for Non PwBD & non CCAA candidates by Western Railways for the Level – 1 Posts of 7th Central Pay Commission (CPC) Pay Matrix against Centralised Employment Notice No. RRC- 01/2019, the shortlisted candidates have been called for Verification of Original documents, verifying genuineness of candidature and medical examination in 5 stages;
 - (i) 1st stage of DV for PwBD & CCAA candidates was held from 1-2-23 to 10-2-23
 - (ii) 2nd stage DV for non PwBD & non CCAA candidates was held from 21-2-23 to 28-3-23.
Further, Document Verification (2nd & Final Chance) of candidates who remain absent in earlier DV was held from 28-4-23 to 5-5-23.
 - (iii) 3rd stage Document Verification for non PwBD candidates was held from 20-9-23 to 26-9-23 and on 29-9-23 (Block Date) for absentees.
 - (iv) 4th stage Document Verification for non PwBD & PwBD candidates was held from 12-02-24 to 21-02-24 and on 27-02-2024 (Block Date) for absentees.
 - (v) 5th stage Document Verification for non PwBD candidates was held from 18-3-24 to 20-03-24 and on 1-4-24 (Block Date) for absentees.
2. On completion of verification of original documents and genuineness of Candidature and Medical examination, in compliance of all other procedures laid down by Railway Board, Railway Recruitment Cell, Western Railway hereby declares the Provisional Replacement Panel part-4 of 143 non PwBD candidates. List of empanelled candidates in ascending order of Roll number is enclosed.



3. Allotment of Posts, Division/ Units shall be decided in due course and shall be subject to availability of vacancies, requisite Medical fitness, Option etc. Offer of Appointment shall be dispatched by respective Divisions/ Units.
4. Merit & Rank shall be declared at a later stage.
5. Result of some PwBD, Non-PwBD & CCAA candidates has not been declared as in some cases the eligibility is to be finalized due to non-availability of certain documents, medical fitness certificates and other administrative reasons and shall be declared at a later stage. Cases of some candidates found fit in B2,C1 are kept pending. Also, cases of PwBD(VI) candidates are kept pending at present in view of Hon'ble CAT-New Delhi' s orders dated 25-09-2023 in OA no.2901/2023.
6. While due care has been taken in preparing the result, RRC- Western Railway reserves the right to make amendments to the provisionally declared panel at any subsequent stage. If any discrepancies or malpractices is noticed or brought to the notice of RRC at any stage, RRC-WR reserves the right to rectify any inadvertent error or typographical / Printing mistakes and declare any candidate unsuccessful or delete the name of candidate from the notified panel.
7. The decision of RRC-WR in the matter shall be final.
8. This is a Provisional Panel and is subject to further changes/ amendment if need arises.
9. RRC will not entertain any individual queries in this regard.
