- 1. Based on the result of Computer Based Test (CBT) declared by Railway Recruitment Board- Ahmedabad on 22-12-2022 and Physical Efficiency Test (PET) conducted from 11-01-2023 to 21-01-2023 at Ratlam for Non PwBD & non CCAA candidates by Western Railways for the Level 1 Posts of 7th Central Pay Commission (CPC) Pay Matrix against Centralised Employment Notice No. RRC- 01/2019, the shortlisted candidates have been called for Verification of Original documents, verifying genuineness of candidature and medical examination in 8 stages;
  - (i) 1st stage of DV for PwBD & CCAA candidates was held from 1-2-23 to 10-2-23
  - (ii) 2<sup>nd</sup> stage DV for non PwBD & non CCAA candidates was held from 21-2-23 to 28-3-23.
    - Further, Document Verification (2<sup>nd</sup> & Final Chance) of candidates who remain absent in earlier DV was held from 28-4-23 to 5-5-23.
  - (iii) 3<sup>rd</sup> stage Document Verification for non PwBD candidates was held from 20-9-23 to 26-9-23 and on 29-9-23 (Block Date) for absentees.
  - (iv) 4<sup>th</sup> stage Document Verification for non PwBD & PwBD candidates was held from 12-02-24 to 21-02-24 and on 27-02-2024 (Block Date) for absentees.
  - (v) 5<sup>th</sup> stage Document Verification for non PwBD candidates was held from 18-3-24 to 20-03-24 and on 1-4-24 (Block Date) for absentees.
  - (vi) 6<sup>th</sup> stage Document Verification for PwBD (LD) candidates was held on 3-7-24, 4-7-24 and on 11-7-24 (Block Date) for absentees.
  - (vii) 7<sup>th</sup> stage Document Verification for PwBD (LD) candidates was held on 29-7-24 to 2-8-24 and on 13-8-24 (Block Date) for absentees.
  - (viii) 8<sup>th</sup> stage Document Verification for non PwBD & PwBD (LD) candidates was held from 15-10-24 to 18-10-24 and on 24-10-24 (Block Date) for absentees.
  - (ix) Non PwBD candidates earlier called for medical examination in A2 to B1 and found Unfit were called for medical examination in Cee one vide Notice dated 6-1-2025 & 15-1-2025.
- 2. On completion of verification of original documents and genuineness of Candidature and Medical examination, in compliance of all other procedures laid down by Railway Board, Railway Recruitment Cell, Western Railway hereby declares the Provisional Replacement Panel part- 8 of 62 non PwBD candidates and Prov. Result of some PwBD, Non-PwBD candidates has not been declared as in some cases the eligibility is to be finalized due to non-availability of certain documents, medical fitness certificates and other administrative reasons and shall be declared at a later stage. Also, cases of PwBD (VI) candidates are kept pending at present in view of Hon'ble High Court -New Delhi's orders dated 22-7-2024 in WP no.9994/2024.
- 5. While due care has been taken in preparing the result, RRC- Western Railway reserves the right to make amendments to the provisionally declared panel at any subsequent stage. If any discrepancies or malpractices is noticed or brought to the notice of RRC at any stage, RRC-WR reserves the right to rectify any inadvertent error or typographical/ Printing mistakes and declare any candidate unsuccessful or delete the name of candidate from the notified panel.
