DECLARATION OF PROV. PANEL PART-14 & PROV. REPL. PANEL PART-10

- Based on the result of Computer Based Test (CBT) declared by Railway Recruitment Board-Ahmedabad on 22-12-2022 and Physical Efficiency Test (PET) conducted from 11-01-2023 to 21-01-2023 at Ratlam for Non PwBD & non CCAA candidates by Western Railways for the Level 1 Posts of 7th Central Pay Commission (CPC) Pay Matrix against Centralised Employment Notice No. RRC- 01/2019, the shortlisted candidates have been called for Verification of Original documents, verifying genuineness of candidature and medical examination in 8 stages;
 - (i) 1st stage of DV for PwBD & CCAA candidates was held from 1-2-23 to 10-2-23
 - (ii) 2nd stage DV for non PwBD & non CCAA candidates was held from 21-2-23 to 28-3-23. Further, Document Verification (2nd & Final Chance) of candidates who remain absent in earlier DV was held from 28-4-23 to 5-5-23.
 - (iii) 3rd stage Document Verification for non PwBD candidates was held from 20-9-23 to 26-9-23 and on 29-9-23 (Block Date) for absentees.
 - (iv) 4th stage Document Verification for non PwBD & PwBD candidates was held from 12-02-24 to 21-02-24 and on 27-02-2024 (Block Date) for absentees.
 - (v) 5th stage Document Verification for non PwBD candidates was held from 18-3-24 to 20-03-24 and on 1-4-24 (Block Date) for absentees.
 - (vi) 6th stage Document Verification for PwBD (LD) candidates was held on 3-7-24, 4-7-24 and on 11-7-24 (Block Date) for absentees.
 - (vii) 7th stage Document Verification for PwBD (LD) candidates was held on 29-7-24 to 2-8-24 and on 13-8-24 (Block Date) for absentees.
 - (viii) 8th stage Document Verification for non PwBD & PwBD (LD) candidates was held from 15-10-24 to 18-10-24 and on 24-10-24 (Block Date) for absentees.
 - (ix) Non PwBD candidates earlier called for medical examination in A2 to B1 and found Unfit were called for medical examination in Cee one vide Notice dated 6-1-2025 & 15-1-2025.
- 2. Empanelment of VI candidates was kept on hold after panel of VI candidates declared on 08-02-2024 due to interim stay granted by Hon'ble CAT- Delhi in OA 2901/2023 filed by Nand Lal Luhar and others. Hon'ble CAT-Delhi has disposed of this OA in favor of Railways vide order dated 16-12-2024. Against this decision, applicants have filed appeal in Hon'ble High Court, Delhi vide WP 9994/2024 and Hon'ble High Court, Delhi also granted interim stay for further empanelment in VI candidates by order dated 22-7-2024. Now, Hon'ble High Court-Delhi vide order dated 1-7-2025 has upheld judgment passed by Hon'ble CAT-Delhi.

3. On completion of verification of original documents and genuineness of Candidature and Medical examination, in compliance of all other procedures laid down by Railway Board and in compliance of Hon'ble High Court-Delhi vide order dated 1-7-2025, Railway Recruitment Cell, Western Railway hereby declares the Prov.
