 - iii. 139 Non PwBD candidates on 3/4 -2-2020, (5th Stage for non PwBD)
 - iv. 24 PwBD (MD) candidates on 5-2-2020, (4th stage for PwBD)
2. On completion of the formalities as per the procedure laid down by Railway Board, Railway Recruitment Cell, Western Railway further declares the Provisional Panel Part- 5 of 102 Non PwBD candidates & 14 PwBD candidates on 18-05-2020.

3. 3 non PwBD candidates (Sr.no.100,101,102 marked as (*)) were found fit in Re-medical examination. These candidates will be required to report Railway Hospital where they were initially examined for completing formalities regarding fresh medical Fitness certificate. After relaxation of Lockdown imposed by Government and regular office work commences, they will be informed suitably by RRC.
4. Allotment of Posts, Division/ Units shall be decided in due course and shall be subject to availability of vacancies, requisite Medical fitness, Option etc. Offer of Appointment shall be dispatched by respective Divisions/ Units.
5. Merit & Rank shall be declared at a later stage.
6. After declaration of prov. panel part-5, total 5724 candidates are empanelled.
