- 1. After empanelling 5861 candidates (Non PwBD 5730, PwBD -131) in 9 Prov. Part panels, balance 226 candidates (Non PwBD- 24, PwBD-202) are to be empaneled.
- 2. Considering balance vacancies & Replacement Indent, **287** non PwBD candidates (UR 181, OBC 45, SC 37, ST 24) and 48 PwBD candidates (LD 11, VI 9, HI 28) are being called for 9th stage of Document Verification.
- 3. Dates of DV for 287 Non PwBD candidates: from 22nd Sept.'2021 to 30th Sept.'2021.
- 4. Dates of DV for 48 PwBD candidate -: 5th & 6th Oct.'21.
- 5. Document Verification will be held at RRC Office, Grant Road, Mumbai. Candidates may refer to "Cut off marks" uploaded separately on website to know their eligibility status for DV. Candidates may note that some candidates from OBC merit are now eligible under UR merit and accordingly called for DV in UR merit.
- Call letter to eligible candidates will be made available shortly on RRC-WR's website.
 Candidates can also see" Venue of medical examination" at the time of downloading call letter.
- 7. Candidates found eligible in Document Verification will be directed for medical examination at nominated Railway Hospital. They are advised to plan their journey from Mumbai to their "Venue of Medical Examination" in advance. Candidates are advised to come prepared for stay at concerned venue for 3-4 days.
- 8. Request for change of "Venue of Medical examination" will not be considered.
- Candidates must carry all the Original Certificates mentioned in the "INSTRUCTION FOR CANDIDATES" of Call Letter. Candidates are also required to carry 6 copies of photographs similar to scanned copy of photograph uploaded in ONLINE Application Form and 6 copies of latest photographs (Photograph taken after 1-9-2021).

10. Candidates may please note that merely being called for Document Verification does not confer any right for appointment to the notified posts.
