- 3 Offer of appointment shall be dispatched by respective Division / Unit.
- 4 Selected candidates will have to give a written declaration as per Annexure 'H' of the Employment Notification dated 4-1-2020. If the candidates violate any of the said declaration furnished by him/her, he/she should be taken up under DA&R by the concerned Authority on the recommendation of the State Chief Commissioner / District Chief Commissioner, as the case may be.
- 5 List of qualified candidates is not as per merit and as per Roll Numbers arranged in ascending order.
- 6 While due care has been taken in preparing in the result, in case of any inadvertent error/s is noticed at any stage, RRC-Western Railway reserves the right to make amendments to the provisionally declared panel at any subsequent stage.
- 7 If any discrepancy or malpractices is noticed or brought to the notice of RRC WR at any stage then RRC WR reserves the right to declare any candidates unsuccessful or delete the name of the candidates from the notified panel. The decision of RRC in the matter shall be final.
